Nothing happens to your photograph until you agree to it. This page sets out the wording you are asked to agree to, so you can read it without a file picker open in front of you.

Before your photo is uploaded

Two boxes, ticked separately. Neither is ticked for you.

I agree that my photo will be processed by AI, including being sent to a third-party AI provider outside the UAE. The photo is of me — not of anyone else — I am at least 18 years old, and it is mine to upload. Our copy is deleted within 72 hours; the AI provider keeps its own copy under its own retention.

I have read and accept the Terms of Use.

Until both are ticked the upload does not open. Ticking them is what starts the processing; nothing happens to your photograph before that.

What you are agreeing to

1. Your photo will be processed by artificial intelligence. It is checked and prepared automatically, then used to generate an image of the selected garment on you.

2. Your photo will be sent to a third-party AI provider outside the United Arab Emirates. This is a cross-border transfer of your data. The provider processes the photo on our instructions, to create your result.

3. Our copies are deleted within 72 hours; the provider keeps its own. Your photo and your result are kept in our private storage, shown only through short-lived private links, never published, never shown to other users, never sold — and deleted within 72 hours. We do not claim they go instantly, and we do not claim the AI provider's separate copy goes with them: that one lives under their retention, explained in [How your photo is processed by AI](#).

4. Your photo is not used to train our models, for facial recognition, for profiling, or for advertising.

5. The result is an AI visualisation, not a photo of reality. Fit, size, length, fabric, texture and colour will differ from the real garment, and the AI can produce visible errors. Do not use the result to choose a size — check the retailer's size guide.

You also confirm that:

- the photo is **of you** — not of another person, and not of a child;
- it is **yours to upload**;
- you are **at least 18 years old**.
